



CRMP Recertification Course Evaluation Form

Certified Reverse Mortgage Professional (CRMP) designees must submit evidence that they earned Continuing Education (CE) credits to maintain their certification status. This means you are responsible for keeping track of the courses you take. NRMLA has provided you with this form to use throughout the year to document your course load. On January 10 of each year, you should submit the form to NRMLA as proof that you have met your CE requirements for the prior 12 months.

The number of credits required in the first year is prorated and determined by the month in which the CRMP is earned. For example, if you became a CRMP in September, you must obtain three (3) CE credits by the end of the calendar year and then 8 credits annually for the duration of the designation's 3-year cycle.

All CE credits must relate directly to reverse mortgages. The 8 Hour SAFE is no longer accepted once you earn the designation.

If a certificate was awarded following completion of a course, please attach a copy of the certificate. Note: You must have completed each course in its entirety. Partial attendance is not acceptable.
