

# HUD National Housing Counseling Activity FY 2020



# National Impact of One-on-One Activity FY 2018 through FY 2020

#### 1,080,494 Clients

Worked with a housing counselor to develop a sustainable household budget

#### 918,449 Clients

Received fair housing information

#### 470,467 Clients

Improved their financial capacity

#### 463,682 Clients

Gained access to resources to help improve housing situation

## Office of Housing Counseling HECM Activity

- A HECM Requires counseling provided by a HECM Counselor.
- HECM Counselors are required to pass the National HECM Exam and work for a HUD-Approved Housing Counseling Agency.
- Since 2018, over **200,000 Clients** have received HECM counseling from the national roster of HECM Counselors.
  - FY 2018 63,371 clients served
  - FY 2019 64,241 clients served
  - FY 2020 70,519 clients served
  - FYTD 2021 19,156 clients served

## National HUD Certified Counselor Progress

- 2,952 housing counselors out of an estimated 3,992 counselors now certified (74%)
- 77% of HUD participating housing counseling agencies now have at least 1 certified housing counselor (as of April 1, 2021).
- 295 HECM counselors (as of April 15, 2021).
  - 240 HECM counselors also certified (82%)

## HECM Program Updates

- In Person Counseling Waiver
  - Waves requirement that all agencies must provide in-person counseling.
- Webinar Collaborations with CFPB on Reverse Mortgage Resources.
  - Recently conducted a webinar on April 13<sup>th</sup> archived on hudexchange.
  - Additional training May 4<sup>th</sup> entitled Preventing Elder Financial Exploitation: Tips & Tools for Housing Counselors.
- HECM Protocol and HECM Chapter 4 of HUD Handbook under final steps of revisions.

### New Online HECM Tools: HLCUT and CBRIT

#### **HECM Loan Comparison and Underwriting Tool (HLCUT)**

- Tracks counselor and agency activity and responses to required questions.
- Provides loan print-outs, amortization schedules, and loan cost analyses.
- Links to other online HECM tools, such as CBRIT, designated by HUD.
- Currently online and in use.

#### **HECM Client Budget and Resource Tool (CBRIT)**

- Provides data on federal, state and local resources.
- Links to other online HECM tools, such as CBRIT, designated by HUD.
- Tool will be available early to late summer.

## COVID-19 Update

Mortgagees must provide delinquent borrowers with notice describing availability of housing counseling offered by HUD-approved housing counseling agencies.

- Most HCAs operating virtually & offering remote counseling to clients
  - CARES Act
  - COVID-19 Information for Housing Counselors
  - CFPB Mortgage & Housing Assistance
